Those attending must adhere to any government/The ICC restrictions in place at the time of the event.

While there are currently no government restrictions on events of this type, we want to ensure the safety of everyone attending the Dinner as much as possible. As part of this we will:

- Require the name, organisation and an email address for everyone attending to be sent to us no
  later than Friday 23 September 2022. These details will only be used by the IPF (and the
  email address will not appear in the list of host/guest names see separate terms). The email
  addresses will be held for 21 days after the event in case the IPF needs to contact everyone to
  inform them of a positive Covid-19 incident at the event. Where there are late changes in individual
  hosts/guests, these details must be provided to the IPF immediately.
- If necessary, we will use the contact details to send any further relevant information, e.g., details of updated access and exit arrangements, to everyone directly prior to the event.

Should government and/or The ICC Covid-19 restrictions and requirements change, these terms and conditions will change accordingly. We will notify you of these changes.

**Cancellation of the event due to Covid-19:** if government guidelines change so significantly that we are unable to run the event, any payment made to the IPF will be refunded in full.

Please Note: Neither the IPF nor The ICC accept any responsibility or liability for a Covid-19 incidence as a result of holding the event.

#### STANDARD TERMS AND CONDITIONS

- Unless otherwise stated, information given in this form will be recorded and held by the IPF for accounting and IPF marketing purposes only.
   We do not share this information with third parties for marketing purposes.
- Organisations wanting one table will need to have one IPF member in the Midlands. Those organisations wanting two tables will need to have a minimum of three members in the Midlands.
- Bookings are accepted in the order of receipt of an emailed signed booking form. We cannot "hold" tables.
- Tables will be for 10 people and must be booked by an IPF member. The IPF will accept bookings for fewer tickets then a full table. Where these are accepted, they will be allocated to a 'shared' table, the composition of which, in terms of other organisations, cannot be guaranteed. Any such tickets must be booked by an IPF member. Places on shared tables cannot be confirmed until sufficient bookings to fill the table(s) have been received.

**NOTE**: no booking exists until you have received a confirmation email from the IPF.

- Payment is required with the booking unless an invoice has been requested. Any request for an invoice must include full details as to the correct addressee and address, together with the purchase order number, if appropriate. All payments for tables/individual places must be received no later than 7 days before the date of the event.
- Cancellations must be made in writing and will be subject to a 10% administration charge.
   No refund can be made for cancellations received after Thursday 8 September 2022.
- Wine/beverage orders:

Full details on how to order/notify us or the venue will be supplied after confirmation of your booking.

• Special Dietary Requirements:

A copy of the menu and a form for notifying us/the venue of special dietary requirements will be supplied after confirmation of your booking.

To ensure dietary requirements are known prior to the event, the menu must be shared with your hosts/quests.

NOTE: Some special dietary requirements, e.g., kosher meals, are likely to be subject to an additional charge, which is payable to The ICC before the event date.
